TRUSU Grants Application #2015-CG-057 The Canadian Society for the Study of Education Annual Conference (Polina Denisova)

Denisova and Howe, Master of Education faculty supervisor, presented the request for a grant to support Denisova's attendance at the Canadian Society for the Study of Education Annual Conference in Calgary from May 28 to June 1, 2016. They explained the purpose of the conference and the value to TRU graduate students to participate. Denisova will present her research about International education and internationalization at TRU. Costs of four days participation will be incurred and the grant would cover those costs.

TRUSU Grants Application #2015-CG-061 The Comparative and International Education Society (Yueqi Wu)

Wu and Howe, Master of Education faculty supervisor, presented the request for a grant to support the attendance of two students at the CIES conference in Vancouver from March 6 to 10, 2016. The students will present their Masters theses to this international conference with a focus on international education. The conference will focus on graphics design and include keynote speeches, panel sessions, incubator sessions with demonstrations, and portfolio exchanges with industry experts. Participation will fit well with TRU's Visual Arts Department curriculum, particularly the skill building workshops in silk-screening, printmaking etc.
