5) Presentations

TRUSU Debate Club - Western Canadian Novice Debate Championships TRUSU Grant

A member presented the request for a grant to support a delegation of first year law students attending the Fall Open Debate Championships in Calgary, Alberta. The championship is being held by an international organization with a Canadian chapter called the Canadian University Society for Intercollegiate Debate. This type of championship provides training for competitive debate, as it is open only to beginners. Attending will be the first step in revitalizing the Debate Club, since the Club leader is currently the only trained debater. The Club will use this as training for Club members to then engage the broader membership. The grant would cover most costs for travel. The Club is collaborating with the UBC Debate Society for bus and group hotel rates. Attendees are paying registration fees.

TRUSU PCMA Club - PCMA Convening Leaders Conference TRUSU Grant

Members of the Club presented the request for a grant to support a delegation of 28 students at the PCMA Convening Leaders Conference in Chicago, Illinois. The Club is a student chapter of a North American organization, providing students with hands on experience in the events industry. This conference is held annually with approximately 3500 delegates representing hotels and accommodations, visitor bureaus, and more, to discuss trends in the industry. The conference provides attendees the opportunity to be actively involved in their own professional development, to networking, and to gain leadership development for Club. The 28 attendees is a large growth this year with many first year students involved. The grant would cover registration fees. The Club will also use banked money and will rely on a number of fundraisers.

TRUSU India Club - Diwali Mela 2014 (Festival of Lights) TRUSU Grant

A member of the Club presented the request for a grant to support an event in celebration of Diwali, the Festival of Lights. This event has been held annually for five years, but this year the Club has changed the name slightly to add "Mela", which means "fair". This year the event will include food, cultural performances, a dance competition (with sponsors and prizes), and fireworks. Last year there were 400 attendees and the Club is expecting the same or more this year. The





Club is selling tickets from tables rotating between buildings and through personal networks.

TRUSU Marketing Club - Fright Night Movie Fest TRUSU Grant

TRUSU Indigenous Law Students Association – ISLA Meet and Greet TRUSU Grant

A member of the Club presented the request for a grant to support an amazing opportunity for students to meet renowned Aboriginal Law lawyer, Jesse McCormick, who focuses on pipeline law. The Club is collaborating with the Faculty of Law, which is hosting McCormick for a lecture, so travel and accommodation costs will already be covered. The grant would cover venue rental, nametags, catering, and beverages. It was clarified that the Union's policy does not allow the funding of alcoholic beverages.

TRUSU Women and Law Club - Persons Day Breakfast TRUSU Grant

Members of the Club presented the request for a grant to support Persons Day Breakfast. West Coast Legal Education and Action Fund previously hosted this annual event, but given their decision not to this year the Club is taking it on. The event is held in honour of Persons Day and Women's History Month and will include a breakfast and guest speakers. Tickets are being sold for \$20 and the grant would support a reduction in the ticket price.

6) Committee Reports

Campaigns Committee

Douglass reported that the committee made a presentation to the Budget Committee of Senate in regard to the Fund the Future campaign and the provincial budget submission. The presentation addressed issues with fees, funding, and financial aid related to targeted outcomes for post-secondary education. The committee will also be preparing membership outreach for the Fund the Future campaign.

In preparation for the municipal election campaign, the committee distributed a questionnaire for candidates with two questions on background and platform and four questions on student quality of life, jobs, transit, and housing. The responses will be published for the membership and distributed at the Meet the Candidates event.

On per credit international tuition fees, the committee has continued discussions with Vice President Milovick and Associate Vice President Chadwick. A substantive update is expected shortly.

Gordon reported that the December 6th Vigil will be jointly planned this year with the Dean of Students and the TRU Faculty Association. Both have been invited to attend the committee meeting this week to develop a campus-wide event.

The committee also debriefed on the Pride Parade and Graduate Students' Development Day.

The policy recommendation will also expand participation in the Steering Committee.

9) Finance Report

Financial Statement - August 2014

Lane reported that this is the first financial statement of the fiscal year, so there are limited revenues and expenditures to report.

In the Unrestricted Fund, there has been minimal revenue realized. Membership fees for the Fall semester have yet to be remitted, and there is limited services revenue. For expenditures, only the prepaid Kickstart expenditures are substantive.

In Health and Dental Fund, fees have yet to be remitted and there are limited opt-in fees. Expenditures include one month of premiums.

In the Capital Fund, fees have yet to be remitted. Expenditures include monthly amortization costs.

Overall, the Union remains in a strong financial position.
