The University Affairs Committee is responsible for the institutional advocacy work of the Union. This includes overseeing the Student Caucus program, submitting TRU governance requests, participating in institutional partnership projects, and directing university lobbying campaigns.

Over the last year, the University Affairs Committee continued to grow its Student Caucus program and encourage meaningful student participation in decision-making across TRU's governance system. Updates included the creation of several consultation sessions, additional student support resources, and new training opportunities.

Also the University Affairs Committee continued several advocacy projects to address student concerns. The University Affairs Committee called for a cap on international student tuition fee increases, collected and distributed feedback for students in TRU residences, and supported several ongoing projects around advising, open education, and campus safety to improve our members' experience with their university.
